From the President

We are completing yet another fulfilling year of ministry here at Brethren Village. I appreciate the opportunity each year to share both my reflections and vision for the future of the Village.

Certainly this past year has been one of growth and success as the Village continues to expand our mission and ministry. Streets and utilities were designed and are undergoing installation as construction of 21-new independent living cottages is well underway. The spacious MeadowCrest cottages are both beautiful and comfortable, adding value and luxury to our expansive campus. I am pleased to report that only four units remain available for new residents to join the Village. If you have an interest in the MeadowCrest cottages, you are encouraged to contact Scott Wissler, Director of Marketing at (717) 581-4261. The first series of these cottages are completed and new residents have moved in. The last phase of the cottage expansion project will be completed in Spring 2007.

In addition, construction has begun on Fairview Meadows, a three-story facility featuring 60 one-bedroom apartments on the east side of the campus along Fairview Drive. In cooperation with the U.S. Department of Housing and Urban Development (HUD), the housing for low and moderate income seniors is slated for completion by April 2007. Demand for these units is strong with more than 75-prospective residents filing applications on November 8, the first day to accept applications.

The Village operations remain strong and we are pleased to report another year of successful financial results. I am thankful and appreciative for a dedicated and professional team of management staff who watchfully balance good business and ministry skills for the benefit of all residents and fellow team members.

It also is with great excitement that we share the vision for future development of the Village campus. As discussed on the front page of this issue, we are pleased to announce a \$90-million dollar redevelopment effort for the Village campus with construction scheduled to begin in 2008. These plans include expanded healthcare and residential living options as well as support services. Announced to residents and team members in October, these plans have been well received. I look forward to sharing more information with readers in the Spring issue of the Villager.

As a grandfather, I have watched our grandchildren enjoy stacking blocks to create a towering structure. They have learned from experience that for a structure to be successful, it requires a solid foundation and hands of support. Likewise, Brethren Village's plan requires a foundation built on obedience to our Father's will as well as support from friends, donors, and the Village community.

We thank God each and every day for the opportunity to serve Him and for the many residents who call the Village home—including all our valued team members and volunteers who labor in support of our ministry.

Financial Information

Greetings! During the past year and as in the past 109 years, Brethren Village provided central Pennsylvania seniors with quality, compassionate care. This tradition of caring has remained constant since the organization's birth in 1897. Over the years, the ministry of the Village has grown and expanded to touch many lives – residents often say "I remember coming here to visit my grandparents and aunts/uncles; then my parents moved in; and now my children and grandchildren come to visit me."

The Village has evolved over this time to offer an array of services and accommodations for individuals of varying backgrounds and means.

We are committed to fulfilling our vision and mission statements by living our core values of caring; integrity; stewardship; and excellence. Although all four core values relate to the organization's success, integrity and stewardship are absolutes in terms of financial results. Regarding integrity, I am pleased to share that our auditors have issued an unqualified, sometimes referred to as "clean," opinion on our financial statements. This represents the highest level of assurance provided by an independent auditor.

Additionally, 2006 represents the second year where our auditors found no adjustments to our financial records. Our core value of stewardship describes the "...use of our time, talents, and resources in a manner which glorifies Him..." The following charts capture the financial highlights of the past three fiscal years and illustrate the organization's growing financial strength – our stewardship of the resources entrusted to us by Him.

The following condensed financial information represents the consolidated statements of operations and balance sheets for Brethren Village and Affiliates for the years ended June 30, 2006 and 2005 as taken from the audited financial statements.

Condensed Statement of Operations

Our total net revenues increased approximately \$1,457,000 - or 6.25 percent, from 2005 to 2006. Revenues are comprised of resident service revenue, meaning services and/or items billed to residents; other operating revenue; contributions; investment income; and net assets released from restriction.

Resident service revenue increased by \$936,000 over the prior years due to increases in rates, including the reimbursement from Medicare and Medicaid, and an improved payor mix. Other operating revenue decreased \$70,000 from the prior year while contributions increased by \$91,000 over the prior year. Investment income increased by \$535,000 from 2005 to 2006. This increase was directly related to realized gains which were \$446,000 more than the prior year.

Additionally, investment income was enhanced by \$89,000 because of higher interest rates. Net assets released from restriction represented the transfer of earnings from our endowment to subsidize benevolent care. The decrease from the prior year correlates with management's plan of reducing this transfer to the lower end of the range permissible under statute.

Our total expenses increased approximately \$1,303,000 – or 5.75 percent, from 2005 to 2006. Expenses are comprised of salaries; benefits; other; depreciation and amortization; interest; and expenses of Brethren Services, Inc. and Brethren Services II, Inc. (Affiliates).

Salaries and benefits increased by \$187,000 and \$105,000, respectively, over the prior year. The increases in salaries and benefits correlated to wage increases for team members and increased costs for benefits, particularly health insurance. Other expenses increased by \$976,000 over the prior year as the result of planned technology projects, enhanced marketing initiatives, and healthcare residents with higher acuity needs. Depreciation and amortization remained relatively flat with an increase of about \$52,000 - considering fixed asset additions of \$1,933,000. Interest expense decreased by \$37,000 from 2005 to 2006 as the result of debt repayment. Expenses of Affiliates increased \$20,000 from 2005 to 2006. Our operating income improved by \$154,000 from 2005 to 2006.

Condensed Balance Sheet

Current assets demonstrated a solid cash position as of June 30, 2006 with 130 days cash on hand and 19 in accounts receivable. Our investments reflected growth over the prior year as the result of reinvestment of realized gains and contributions to restricted funds. Property and equipment decreased by \$965,000, considering the net impact of capital additions and depreciation. Other assets increased by \$141,000, primarily because of improved market value on a perpetual trust, of which Brethren Village is a named beneficiary.

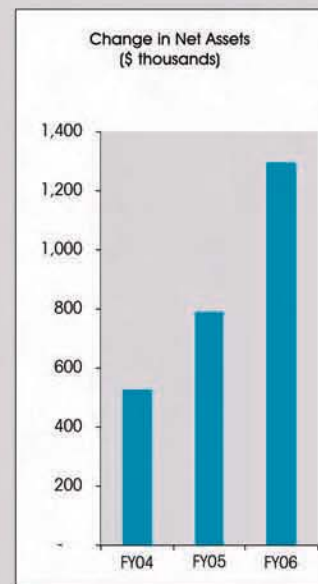
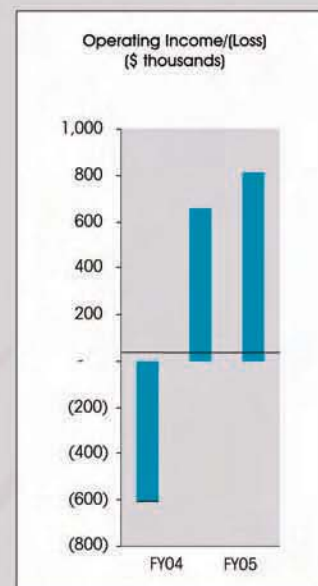
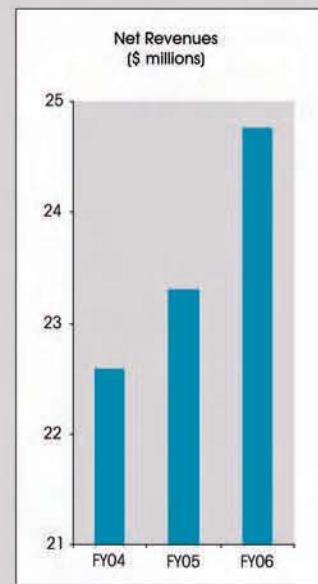
Current liabilities decreased by \$398,000 as the result of variation within the payroll accrual. Decrease in annuities and other liabilities of \$781,000 stemmed from a drop in the termination value of our interest rate swap. Long-term debt decreased by \$404,000 as a result of repayment of debt. Decrease in unearned entrance fees of \$345,000 represented the net effect of the following: new entrance fees of \$2,439,000; refunds of \$756,000; and amortization of \$2,028,000. Net assets increased by \$1,694,000: more specifically, unrestricted net assets increased by \$1,297,000; temporarily restricted net assets increased by \$93,000; and permanently restricted net assets increased by \$304,000.

As we look to our past for strength and courage, we look to our future with excitement and passion. As we move into fiscal year 2007, our organization and its team members share the goal of continuing our tradition of caring – the standard of excellence in caring for our seniors. Together we look forward to advancing the organization's vision statement: Enriching each life touched by our ministry.
