Meet Polly Kilheffer

Polly has lived at Brethren Village for four-and-a-half years in Oakwood House and enjoys being involved in many of the Village activities such as Life Story writing, singing in the BV Choir and Jewelry with Rose. I first met her while taking pictures of Rose's jewelry class in the Creative Arts Room. She's a pleasant, quiet woman with a warm smile...but when I asked Polly about her dollhouse, her face broke into a huge grin and her eyes twinkled with excitement as she described her dollhouse to me.


When I met with Polly her dollhouse was decorated for winter, complete with wreaths that she made herself and frost gathering in the corners of the windows. There's a Christmas tree in the parlor and logs of wood stacked on the back porch. Snow covers the bushes, lawn and roof, and icicles dangle from the eaves.

cold scene outside our own windows, Polly talks about the dollhouse and recalls her childhood memories with infectious warmth.

Polly's treasured dollhouse was a gift from her husband, Bob, more than 40 years ago. It was a standard kit but she and Bob changed aspects of the house that she didn't like. Polly changed the floors, added shutters, handmade curtains for the windows, braided area rugs for the floors and sewed quilts for

the tiny beds. The vanity dresser in one of the bedrooms reminds Polly of a trip to New Zealand she took with Bob. She recalled that she window-shopped while he was in meetings and when she met him for lunch she told him about a dresser she found and loved, but she didn't buy it because it was expensive. He asked her to show it to him and he bought it for her. It's clear that cherished memories from her life are exemplified in the dollhouse that she changes with each season.

Although her birth name is Mary, "Polly" was a nickname given to her by her beloved grandfather. His mother's name was Paulene, and he called her his

"little Polly." She loved the special name her grandfather gave her and made it the name she goes by. She affectionately points out a photo of her grandfather holding her in a wall frame in one of the bedrooms. Polly purposefully modeled specific aspects of the dollhouse after her grandparent's house that she frequented growing up. The address numbers are alphabet soup pasta numbers

that she painted and glued on 30 years ago. The dry sink in the kitchen, the piano in the parlor, the curtain partitioning off the bathroom are all loving replicas of the house she's grown to cherish.

Looking even closer at the scenes that come to life before you, one can't help but notice the exquisite life-like details. As Polly says, "The details are important, they make it look real." When she sees something that is just

the right size, she finds the perfect place to use it in her dollhouse. Sometimes making an item from scratch is more realistic than a pre-made item, like the lamp post on the front walkway that Polly created herself from a small glass bottle and a wooden dowel.

Polly stresses that she's not an artist, just a creative person. But her creations paint a different picture. Oil paintings that she's done adorn her apartment walls and she tells me they are already spoken for. Her grandchildren love looking at them and they will each get one. Her dollhouse, though, is the center of attention. When her grandkids visit they always want to play with it, but Polly stresses, "It's a display of a house, not a toy."

However it's not simply the display of a house, Polly has taken great care to portray her fondest memories and preserve them in vivid detail throughout her treasured dollhouse.

Did You Know That BV Recycles Styrofoam?

Brethren Village is one of only a few retirement communities committed to improving the environment and limiting landfill trash by having a Styrofoam recycling program. In 2013, over 400 bags of Styrofoam were taken to the Dart recycling center. According to the Dart recycling website, Dart's sustainability efforts save enough energy each year to heat more than 105,000 homes.

The Environmental Care Group of the Green Thumb Society has been actively recycling Styrofoam at Brethren Village since 2011.

In 2010, Lucy Eyster, of Woodcrest Villa, met with BV Resident Council members to discuss the Styrofoam recycling program at Woodcrest Villa. Following the Resident Council meeting, Bob Allen, who served as President of Resident Council at the time, approached

Connie Brown, a member of Resident Council, about developing an emphasis on environmental care at BV. Dottie Ezard worked with Connie and the soon-to-be group received significant support from Ron Dell, Gary Gaissert, Ken Beam and other administrators. Over the years, this effort has become the Environmental Care Group within the Green Thumb Society.

Styrofoam never completely biodegrades and it requires separate recycling and delivery to a recycling center. Representatives from Dart Corporation came to BV to educate the group about the process. Styrofoam is melted down into small pebbles and sold to companies who make artificial wood and plastic products — such as picture frames and outdoor tables and benches. Packing peanuts are not recyclable, but the group still collects them and gives them to local potter Steve de Perrot, of Pots by de Perrot, to use in packing orders for shipping. Steve's father, Jon de Perrot, is a BV Resident and member of the

Connie, along with a team of dedicated volunteers, implemented the Styrofoam recycling program at BV by placing special boxes in the trash rooms to collect Styrofoam and educating Residents and Team Members that they can now recycle Styrofoam. Dining Services supplies the group with large, transparent bags and Connie, Bernie Jacobson, Ned Evans, Fran Knedeisen, and Pat Beamsderfer collect Styrofoam from the trash rooms at least once a week.

It's a time-consuming process. For example, Bernie is responsible for four sites in Fieldcrest East, and spends about an hour and a half a week collecting and nesting the Styrofoam from the collection bins so it best fits into the transportation bags. There are collection sites at Fieldcrest, Fairview

Meadows, Village Garden, Townhouse and Oakwood House. Cottage Residents bring their items to the Fieldcrest collection sites. Once all of the Styrofoam is collected, the bags are taken to the storage shed in Fieldcrest. Jon de Perrot and Sid Long load the bags (usually 8–10 large bags, plus Styrofoam shipping aids and coolers) into Jon or Sid's vehicle and they are delivered to the Dart Recycling Center on Pitney Road.

"Residents' efforts to clean and deposit the Styrofoam we use help both present and future generations. Your stewardship matters!" said Connie.

Connie mentioned that the group could use additional volunteers to collect the Styrofoam and help transport the bags to Dart. "It's light work and more volunteers make it even lighter work!"
