Four Leaders, One Retirement Community

Brethren Village is definitely not "where old people go to die." Our Residents were once business leaders, teachers, pastors, doctors, nurses, artists, homemakers, military veterans, mothers, fathers, and volunteers. All have had unique experiences before coming to Brethren Village and within the Village exists a depth of intellectual talent that most would be surprised to learn of.

Four of Brethren Village's current Residents held the role of Annual Conference Moderator within the Church of the Brethren. Charlie Bieber, Curtis Dubble, Guy Wampler and Earl Ziegler, all pastors' emeriti, held the highest elected office in the Church of the Brethren. The Annual Conference Moderator serves as the spiritual and official head of the Church of the Brethren and is directly responsible for the yearly national conference. At Annual Conference, delegates representing 23 districts take a stance on behalf of the church on public issues such as: war, the death penalty, abortion, women in the ministry and environmental issues. Plenty of non-delegates also attend, but only delegates can vote. In addition to business sessions, the Annual Conference also consists of worship, fellowship and educational sessions.

How did you decide to enter into ministry?

CB: I grew up Methodist but later converted to the Church of the Brethren. The church called me to ministry. I knew I wanted to be a missionary and it was my belief that missionaries should also be pastors. When the church tells you to do something, you do it!

CD: When the second World War broke out I was a conscientious objector, so I spent more than three years doing work of National importance. My late wife, Anna Mary, had a strong influence on my becoming a minister. We were engaged when she attended Seminary School in Chicago. She was surrounded by men also studying to do God's work...I suddenly realized they were competitors! Seriously though, I knew I wanted to do something where I was helping people through the church.

GW: When I graduated from high school, I wasn't even thinking of a

career in ministry. I thought I'd go into business, but the church called me to be licensed (that is, a one-year trial to get a feel for ministry and see if it was a good fit.) You could say it was a natural progression since the Brethren faith can be traced within my family back to the 1700s.

EZ: During high school I debated between being a medical doctor and a minister. I felt the call of God on my life to a set-apart ministry and that call was affirmed by a circle of friends in my home church.

How did you come to be Annual **Conference Moderator?**

CB: I was proud to be Annual Conference Moderator but I wasn't looking for notoriety. A district executive called me and asked if he could put my name on the ballot. I said no, but he was persistent. He assured me I would never get elected, he just needed help filling out the ballot. So I agreed, and I was elected. That happened several times

throughout my life – I didn't necessarily seek things out, God called me to them.

CD: I was elected Annual Conference Moderator after I retired as pastor, but before I served as interim pastor of the Lancaster Church of the Brethren. It was an honor to be elected, and I was invited to churches across the United States because of my role as ACM.

GW: I did not actively seek out becoming Annual Conference Moderator, I would say that most pastors don't, though they may dream of attaining the position. I preached at Annual Conference several times when I was a young pastor and then I served on the National Board. Some of my sermons and articles were published in the denominational magazine so I think my name got "out there," so to speak.

EZ: I served on planning committees and was also a member of the National Board. I was elected by the delegate body and believe that my God-given gifts of leadership, with a good understanding of the mission of the church, as well as a spiritual depth in relating to all of the congregations, were beneficial in holding such an important role.

How did serving in that leadership position affect you? What impact do you feel you left?

CB: I was proud to be Annual Conference Moderator. It was a busy, heavy year as we decided women's place in the ministry. As a District Minister, I helped more than a dozen women attain pastoral positions at a time when women were having a hard time securing leadership roles. Ultimately, God called and I responded and I feel satisfied with the things I've accomplished in doing God's work.

CD: I learned that there are a lot of good people in the organized church. Also, I have gifts to share and God gave me opportunities to use them. I was once a little country boy who was hired by a farmer to pick potatoes working with a gentleman who was on death row. (*side note: Guy worked with the mother of the gentleman on death row and did his own research on the case. He presented enough evidence to get the person a new trial and he was ultimately found not guilty of the crime.) To be a successful ACM, you need to be fair to all delegates and gain their trust.

EZ: The year I served as ACM the issues before the church were homosexuality within the clergy and how to incorporate non-white parishioners. I've been to the Dominican Republican more than 20 times since 1991 helping to build, develop and grow churches as well as plan summer bible schools. I have also served on the National Korean committee, so I had a vested interest in helping these parishioners, particularly those of Korean and Hispanic background, become full members in the church.

Why did you decide to retire at Brethren Village?

CB: Mary Beth and I always knew Brethren Village would be our home one day.

CD: My mother was a Resident at Brethren Village and Anna Mary and I knew we would come to Brethren Village to retire. I was actually courted by two other area retirement communities to live there and serve as their chaplain, but we always knew Brethren Village would be our home.

GW: Linda and I like Lancaster and have lived here a long time. I've visited people at Brethren Village for many years as their pastor. The Village is very attractive, has great staff and values, and is open to all kinds of people. We also know a lot of people from Lancaster Church of the Brethren who live here.

EZ: Brethren Village began as a farmhouse in Manheim in 1897, established through church member offerings. My wife Vivian's great grandfather was part of the original group who felt that the church should provide a house for the poor, aged and infirmed. Additionally, Vivian's mother was a Brethren Village Resident and I guess you could say that we always felt Brethren Village was a good fit for us. Four Church of the Brethren pastors from different backgrounds and upbringings have two things in common. They all served the church as the highest elected official, and they all came to be Residents of Brethren Village where they continue to engage the community and be enriched by those around them.

Insider Secrets to Effective Wills



Wills are one of those things that you don't like to think about.

Yet, wills are one of our most important personal documents. A well written, updated will assures that our last wishes will be heard and that our earthly assets will be distributed according to our desires.

Where to start:

1. Make an appointment with your attorney. If you don't have an attorney, ask a friend or relative to recommend one or contact our office for a list of local attorneys who deal in estate planning.

2. **Prior to your appointment determine your goals.** Who should be your executor? Who will

receive your property and how will it be divided? Would you like to remember a favorite charity such as Brethren Village and help them to further their ministry with a charitable bequest?

3. Follow through with your plans to have a well written will. Your will can be an expression of your personal goals, beliefs and values.

4. Store your will in a safe place and review it periodically to assure that it is up-to-date. If the time comes to make changes to your will, a simple codicil is often all that is needed.

Sometimes, people write their own wills, called holographic wills. Or, they may print out a "fill in the blanks" form off the internet. Unfortunately, such wills can also have problems that render them ineffective. So be careful, if you choose to write your own, ALWAYS have it reviewed by an

and I ended up being elected Annual Conference Moderator. The experience taught me it's not where you come from but who you are and that you can make a difference.

GW: During the year that I served as Annual Conference Moderator, the topics that were on the floor were tough. The church was to take a stance on capital punishment, AIDS and genetic engineering. One delegate raised the question whether I should preside during the session on capital punishment. He wondered whether I would be able to remain neutral as a presiding officer since I had been experienced attorney.

Well written wills make estate settlement go quicker and with less expense. It is worth it to make sure your will is clear and effective and that taxes and fees have been minimized as much as is legally possible. This is also a good time to make sure beneficiary designations in life insurance policies, pension plans, IRAs and annuities are up-to-date as well.
