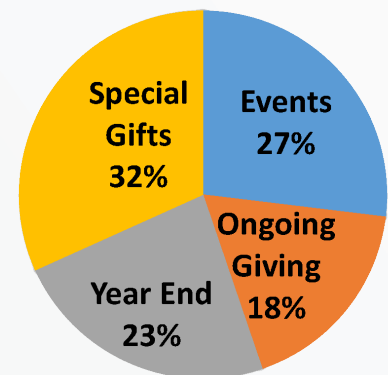

One-Pot Creamy Pasta & Broccoli

Recipe—makes 2 servings

Ingredients

Water—2 C	Apple cider vinegar—2 t
Wheat flour—2 T	Mustard—1/2 t
Garlic—2 cloves	Frozen broccoli—2 C
Paprika—1 t	Nutritional yeast—1/2 C
Pasta (Whole-grain or Gluten Free)—2 C	

Directions

1. Bring the water to boil in a saucepan. Choose a pan that can fit all the ingredients together.
2. Peel and mince the garlic.
3. Once the water is boiling, add the pasta. (Keep the water in the pot once the pasta is cooked!)
4. In a bowl, mix flour with equal parts water and stir in the apple cider vinegar, garlic, and mustard. Stir until combined. Add this mixture to the pasta (with the water used to boil the pasta) and gently stir until the flour mixture has dissolved into the water. Continue cooking for about 7 minutes.
5. Add the frozen broccoli and continue cooking until the broccoli is heated throughout and the pasta is cooked.
6. Turn off the heat as soon as the pasta is done. Mix in the nutritional yeast, paprika, chili pepper flakes (optional) and salt and pepper to taste. For extra flavor, choose a smoked paprika. Or, add in pickled or fresh jalapenos. This base dish can be adapted in many ways according to what you like best. Or, just enjoy as is!
