## We care about the impact in our community

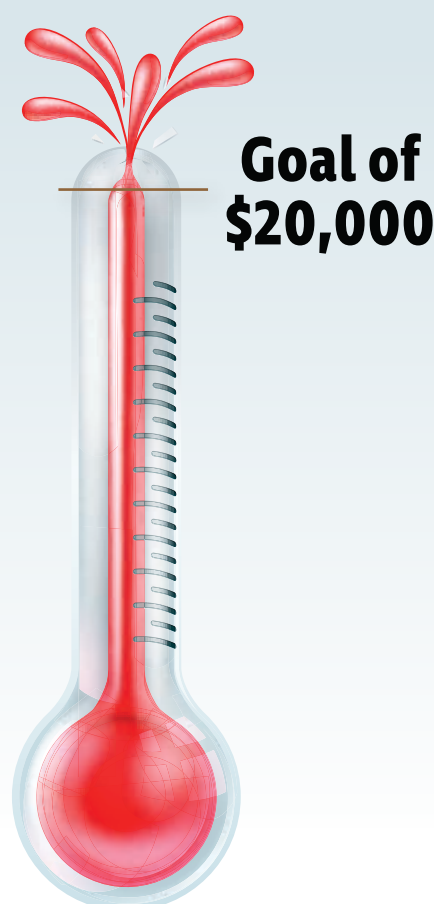

## Close the gap for the Good Samaritan Fund

Recently our Development department sent an appeal to raise \$20,000 to close the gap between what we expected to raise at our annual Good Samaritan Banquet and what we received by the time we had to cancel this year's event in March due to the pandemic. We were overwhelmed by the response, having received just over \$75,000 to date, exceeding our goal by 3 times! In 2019 the Good Samaritan Banquet raised \$65,287 for the Good Samaritan Fund. This year we received \$123,497 between the registrations and the proceeds of the close the gap appeal. This is an 89% increase over 2019. Thank you! 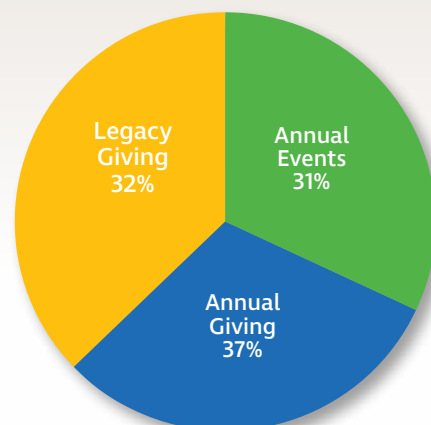

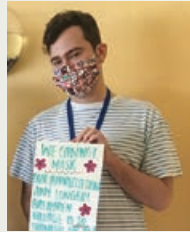
